



Pick-Up/Drop Off

Lanes in front of the terminal have been reduced and it's important to remember that curbside parking is NEVER permitted!

- Use the cell phone/observation lot on Albany Shaker Road to wait for arriving passengers.
- Once they're curbside, you may drive to the front of the terminal and quickly pick them up.
- Use the short term parking lot for picking up and dropping off passengers.
- 4 Passengers should also consider alternate transportation such as Uber and Lyft which can be accessed in designated locations outside of the terminal.





September 13, 2023


Our Communication Goals:

 - Preventing congestion in front of airport






